Subj: USE OF OFF-ROAD RECREATION VEHICLES ABOARD MARINE CORPS LANDS

Ref: (a) MCO 5090.2

1. <u>Situation</u>. The use of off-road recreation vehicles (ORRVs) is increasing in popularity as a form of recreation. Reference (a) defines ORRVs as any motorized vehicle designed for, or capable of, cross-country travel on, or immediately over, land, water, sand, ice, marches, swampland, or other natural terrain. This term excludes any registered motorboat; any military, fire, ambulance, or law enforcement vehicle when used for emergency purposes; any combat or combat support vehicle when used for national defense purposes; and any vehicle use that is authorized by the Headquarters Marine Corps Installation and Logistics Department, Facilities and Services Division or a representative thereof for official use under a permit, lease, license, or contract. Public lands, including military lands, are being subjected to pressure from individual and organized ORRV interests for access to these lands. However, this form of recreation frequently conflicts with military land use requirements, wise land, and resource management practices, environmental values, and other recreational activities.

2. Cancellation. ASO 5090.7A

3. <u>Mission</u>. To establish policy for use of ORRVs in accordance with the reference in order to facilitate environmental protection of public lands entrusted to MCAS Beaufort.

4. Execution

a. Commanders Intent and Concept of Operations.

- (1) <u>Commander's Intent</u>. To restrict all ORRV use on any land and water areas under Marine Corps Air Station (MCAS) Beaufort control and to limit official use of Government vehicles for off-road travel to what is absolutely required for security, safety, or operational necessity.
- (2) <u>Concept of Operation</u>. As a trustee of public lands, MCAS Beaufort has a responsibility to protect and enhance environmental quality, conserve natural resources, and provide opportunities for outdoor recreation. Accordingly, the following policy regarding the use of ORRVs is hereby established:
- (a) All land and water areas under MCAS Beaufort control shall be closed to off-road travel by ORRVs .
- (b) The limitations imposed by this Order do not apply to the official use of Government vehicles for off-road travel.

5. Administration and Logistics

a. The Natural Resources and Environmental Affairs Office (NREAO) shall bear primary responsibility for implementation and enforcement. The NREAO Conservation Officer shall act as the primary enforcement provider with assistance from the Provost Marshall's Office as required.

b. Controlled Unclassified Information (CUI)

- (1) Unless specifically marked as classified (e.g. Confidential, Secret, and Top Secret) the following are categories are subsets of Controlled Unclassified Information (CUI) and are to be protected in accordance with 32 CFR Part 2002: Agriculture, Critical Infrastructure, Emergency Management, Export Control, Financial, Geodetic Product Information, Immigration, Information Systems Vulnerability Information, Intelligence International Agreements, Law Enforcement, Legal, Natural and Cultural Resources, NATO Controlled, Nuclear, Patent, Privacy, Procurement And Acquisition, Proprietary Business Information, SAFETY Act Information, Statistical and Tax.
- (2) All individuals handling this information are required to protect It from unauthorized disclosure. Handling, storage, reproduction, and disposition of the attached document(s) must be in accordance with 32 CFR Part 2002 and application agency policy.
- (3) Access to and dissemination of Controlled Unclassified Information shall be allowed as necessary and permissible to any individual(s), organization(s), or grouping(s) of users, provided such access or dissemination is consistent with or in furtherance of a Lawful Government Purpose and in a manner consistent with applicable law, regulations, and Government-wide policies.
- c. Records Management. Records created as a result of this Plan shall be managed according to national archives and records administration (NARA) approved dispositions per SECNAV Notice 5210 Implementation of New Department of the Navy Bucket Records Schedules and MCO 5215.1K Marine Corps Directives, to ensure proper maintenance, use, accessibility and preservation, regardless of format or medium. Refer to SECNAV M-5210.1 Records Management Manual and MCO 5210.11F Marine Corps Records Management Program for Marine Corps records management policy and procedures.

6. Command and Signal

- a. This order is effective immediately upon the date signed.
- b. This order is applicable to all personnel aboard MCAS Beaufort but does not apply to Government contractors or agency representation acting in the course of their employment requirements.
